# SEWA RURAL

SEWA Rural has been engaged in health and other developmental work in south Gujarat's rural and tribal area for **41** years. After education and experience in India and abroad, some friends started this work in 1980 to fulfill Swami Vivekananda and Gandhiji's ideals as much as possible. Like-minded individuals joined over a period of time.

SEWA Rural tries to help the **deprived and poor,** through health and developmental work, after taking into account society's needs and the available manpower. Hand in hand, effort is made to maintain **moral values** and administer to the **overall development of its employees.** In all activities, the focus is the underprivileged in society and family such as the poor, women, children, and the elderly.

**Social service, scientific approach** and **spiritual outlook** make the foundation of all activities in SEWA Rural. Special effort is made harmonize these three.

The various activities of the organization include the following. 250-bed **Kasturba Hospital** through which more than 2000 neighboring villages are able to get state-of-the-art health services. The **Community Health Project** covers four talukas of Bharuch and Narmada districts. In it, ASHA workers with the help of "ImTeCHO" a special mobile software, provide regular services to pregnant women and newborns in every village and thus decrease maternal and newborn mortality. The **Women Health Training Centre** provides health training to about 1000 trainees every year from about 50 voluntary organizations in Gujarat and other states, government workers as well as college students in India and from abroad. It works towards empowerment of adolescents through multidimensional program. The **Eye programme** provides the most current eye treatment to a 20 lakhs population in Bharuch and neighboring districts. The **Vivekananda Gramin Techniki Kendra** provides 2-year practical and vocational training to about 200 partially educated young men and women every year. Afterwards, they are able to get employment in industries or become self-employed. The responsibilities of various women awareness, empowerment and economic activities started in 1985 by SEWA Rural, have been taken up by the women themselves in the form of **Sharada Mahila Vikas Society** in July 2002.

SEWA Rural has some noteworthy accomplishments. The goals set by "Health for All by 2000 AD" have been achieved many years ago by the successful functioning of the Primary Health Centre, handed over by Gujarat government during 1980s and 1990s. SEWA Rural's First Referral Unit, acknowledged by Gujarat government and UNICEF, provides special treatment to high risk patients during delivery and newborns in Jhagadia and nearby talukas. In 1998, the 2.5 lakh population of Jhaghadia and Valia became cataract-free. More than 3000 women and youth have become economically self-reliant through various projects and training programmes. The Blind Rehabilitation programme was successful in rehabilitating 550 blind people of 7 talukas independent through various means. Some programmes have been scaled up by state government.

SEWA Rural believes in working with all the stakeholders of society such as local community, Indian and international voluntary organizations, government, private industries, educational organizations and so on. As a result, SEWA Rural's goal of benefits of development reaching the deprived sections of society such as women, children, elderly and the poor, becomes stronger.



# Dear Friends

We are happy to present SEWA Rural's **41**<sup>st</sup> **Annual Report** for the year **2020-21** among all of you.

All of us are still facing the pernicious effect of the Covid 19 pandemic which started last year. SEWA Rural had to confront it in our hospital and other departments. Despite that, workers at all levels continued their duties bravely. As an organization, we conducted many activities focussing on the pandemic last year and have discussed them in this report under a separate heading. Apart from this, well-wishers and sincere friends like you supported us economically in this crisis, due to which we continue our work for the poor with confidence.

In the last several years, there has been a shortage of space on our hospital premises due to the ever-increasing number of patients. Due to this, we shifted many departments to our Gumandev campus two years back and are now planning a large scale hospital expansion project on our main campus. We will demolish some old structures and build a new building with a basement and four floors. With this expansion, we will solve the space issue as well as enhance the safety and quality of care for patients. For this new project, we require 25 crore rupees for the construction of the new building and related hospital equipment. We have faith and confidence that we will get support from society.

In this 41<sup>st</sup> year annual report, the progress of various activities and audited finances have been presented. Your suggestions are welcome. We hope that your good wishes and support will continue, as it has for the past four decades during the various ups and downs of SEWA Rural.

# The Year at a Glance

01

- During this Covid pandemic, many relief activities were conducted by SEWA Rural. Last year we distributed almost more than 1000 food kits to ultrapoor families. We also made and installed handwash stations in 42 public spaces in Bharuch and Narmada Districts. We took scientifically proven preventive steps for the safety of our workers and beneficiaries at all levels. We established a Covid Vaccination Centre in our hospital. During the second wave of the pandemic, we started a Covid Helpline for home-quarantined Covid patients. Our physician even offered his services to the district government Covid hospital, considering it our duty as an expert at both the hospital and field levels.
- Due to the pandemic, we faced a financial crisis last year. We started a donation campaign so that our activities could continue and we got generous support from well-wishers and friends. During this period our workers helped by not taking salary increments on our request. We also increased hospital charges for affording patients but continued giving free or partial charges for poor patients as before. Last year 70% of indoor patients availed themselves of these benefits. Due to these steps, we successfully overcame the economic crisis.
- Last year 1,35,248 beneficiaries were helped through different activities of the

organization. During this pandemic situation, we continued regular hospital services throughout the year and thus patients were benefited from this crisis.

- Last year we also focused on strengthening the management process. Many statuary laws have been formed by the government for voluntary organizations. Following them is not easy but we satisfactorily implemented them.
- We improved different management information systems (MIS), mainly the accounts and supervision systems in all departments. We also renewed our fire and safety certificates.
- We started some new activities as well. From January 2021, weekly outpatient care and sonography service along with a well-equipped laboratory for obstetrics and gynaecology at a remote area of Dediyapada in the Narmada district began. In society, mental ailments and complaints are increasing so weekly psychiatric outpatient care in our hospital was started from which more and more patients are being benefitted. We also started a small but important comprehensive primary health care service in a small village. Here, we focus more on non-communicable and mental health disorders.
- We wanted to do something about the education of migrants' children so started educational classes on a farm at a time convenient to them.



- For accurate diagnosis of sickle cell disease in newly born babies, we procured a new HPLC\_2 Variant Machine with the help of ICMR, Delhi. We were also one of the organizations in India for community-based multicentric research for newly born sickle cell disease cohort follow-up.
- In VGTK, production was increased to almost 200% and all workers were busy the entire year.
- From 21<sup>st</sup> September 2021, we have started a waiting cum triage room for pregnant women. This was more systematic and pregnant women shifted to the labour rooms as per the triage protocol. This system is very popular among all our pregnant patients.
- From the Government of Gujarat (District Governing body- Bharuch), SEWA Rural got the certificate of "Best Performing Trust Hospital" for availing of various government health schemes.
- As per our commitment to developing the second cadre, Dr Gayatriben Desai took charge of Medical Director in the hospital in September 2020. We are very happy to be able to uphold our resolve year by year. The second level of leadership is taking responsibility for various activities under the mentorship of seniors.
- We planned many meetings with different stakeholders like previous employees of SEWA Rural, village level workers and VGTK alumni. We informed them about new developments and programmes in

SEWA Rural as well as the issues due to the pandemic. We also got feedback from them about the improvement of our hospital services.

- On 23rd January 2021, we had an online get-together of our foreign well-wishers. They were updated about new programmes and changes and we also got ideas to improvise our services.
- We have been certified as a "Great Place to Work" for the past five years and are in the top ten NGOs in India. Also, for five years in a row, Gold Star India has certified us in the Gold Category for our transparency, accountability, and reliability.



# Covid-related prevention and Remedial activities by SEWA Rural and Sharda Mahila Vikas Society

04

During 2020-21, the entire world went through great anguish due to the Covid pandemic. The Covid relief work done by SEWA Rural is symbolic and obviously on a smaller scale. But we are pleased to say that we put in our share with sincerity and dedication. Our wellwishers supported us in the economic crisis created by it. Our workers acted as a team and worked fearlessly. We were also able to uphold our values and retain the faith of our beneficiaries in us. With the grace of God, we came out stronger and purer. The work done is given below.

### 1. Distribution of the Food Kits :

Food kits were distributed to 3,289 people from 1,000 antyoday (very poor) families. They were mostly poor landless labourers and these food kits helped them very much in the first lockdown. We also distributed 125 food kits to the disabled in Bharuch and Narmada districts.

- 2 Hand Wash Station : With financial assistance from UNICEF, we installed 32 handwash stations in all the PHCs and CHCs and the Civil Hospital in Rajpipla. With the support of Meggar Company, we also installed 10 handwash stations in schools and public places in Jhaghadia. These handwash stations were made in our technical institute.
- **3 Distribution of the Covid Hygiene Kits :** We distributed 1,400 Covid hygiene kits to infected patients, their families and neighbours free of cost. With the help of Meggar Company, we also distributed 2,000 sanitisers and

cotton masks to school teachers, health and ICDS workers, the police department, state transport department, banks, local vendors, students of our technical institute and our staff.

- **4. Covid vaccination centre :** We started a Covid vaccination centre in which vaccines were administered at a reduced price. Instead of Rs. 250 per dose, we charged Rs 150.
- 5. Full Vaccination for the Health Staff : Among workers involved in health activities and eligible for Covid vaccination as per government norms,

95% took both the doses of Covid vaccine. Due to this, infection among our staff was less during the second wave.

- 6. **Public Awareness :** For schoolgoing children, we prepared a poster "Come back to School", which were described the precautions they should take in school. We put up posters in 3 schools, 10 boarding schools, 11 villages, as well as various departments of SEWA Rural such as the technical institute, tutorial classes, training centre and hospital campus. We conducted a session to create awareness too.
- **7. Continue Medical services :** Many hospitals closed down during the pandemic. We are proud that though some of our staff were infected and there were high chances of further infection, our health services continued with the support of our staff.
- Safety of Medical staff, front-8. line health workers, patients and their relatives : 1. From the very beginning of the pandemic, we took various preventive steps in the hospital and organization due to which not many got infected. We screened everyone who entered the main gate. On a daily average, more than 700 people were screened. We also started a "Fever Clinic" at the main gate. We ensured that the mouth and nose of every person entering were covered either by a mask or a simple cloth. Our workers sanitized our campus with sodium hypochlorite twice daily. To protect patients and maintain social distance in the hospital, we shifted a few

Screening & Hand hygiene at Hosp. Entrence OPDs like Paediatrics, Ophthalmology and Gynaecology from morning to afternoon. We have had an infection control committee for a long time now and this committee monitored the preventive measures taken. We gave simple masks, triple-layer masks or N-95 masks to our employees as per their work and responsibility. If any of our workers had a cough, cold or fever, they were tested for Covid as per the doctor's advice and stayed at home. We were more liberal in giving sick leave and even gave additional leave to those who had to be quarantined. The entire staff attended a session on Covid in which they learned how to wear a mask and other related topics, conducted by us.

9. Free Covid Helpline for the Home Quarantined Covid patients: We started this helpline with the help of medical doctors, lab technicians and field supervisors. We also gave thermometers, SPO2 Monitors, essential drugs, and laboratory tests free of cost at their doorstep and monitored them twice daily by phone.

- **10. Other Departments :** Due to Govt. guidelines for the pandemic, many of our staff, mainly from the technical institute and tutorial departments, had no work. All of them contributed to other departments, primarily in the hospital. In fact, in VGTK the production increased up to 200%.
- 11. Economic crisis & Cutback : Due to the pandemic, our regular government grant was delayed and we had to face an economic crisis. So, we took some cutback measures and were able to save more than 15% recurring money. Our employees did not get yearly increments and some of them even donated to the organization. Most of the senior workers took reduced salaries. Well-wishers responded wholeheartedly to our donation appeal. We increased our hospital charges, but poor patients continued to get free treatment as before. We spent **Rs. 45,63,242** for the prevention of Covid to which many well-wishers donated.
- **11. Special Covid Care hospital :** We started a free 30-bed special Covid care hospital during the second wave. There were 18 beds with oxygen facility and 12 beds without it. We even installed an oxygen plant to ensure a continuous supply of oxygen. This special hospital proved to be a blessing for the nearby rural and poor patients.
- 12.Our physician offered his medical expertise to the District Hospital in Bharuch for almost 2 months while they faced a severe lack of medical consultants.






# A glimpse of major activities

• Kasturba Hospital has been a boon to poor patients in our area due to quality treatment facilities and a humane approach towards patients. People from more than 2,500 villages came to the hospital from Bharuch, Narmada, Vadodara, Surat, Tapi and villages bordering Maharashtra.



- Tribal patients constitute 56% of the hospital's OPD and 61% indoor.
- We conducted a sample survey of our patients as per the SECC 2011, Government of India scale for below poverty line, and found that 31% of our patients were below the poverty line.
- Due to the pandemic, the number of patients was significantly lower than the previous year.







# Raam rakhe tene kon chakhe Nothing bad will happen to people protected by God

A 47 years old male muslim patients from village Kapalsadi had come to OPD on 2<sup>nd</sup> Dec 2021 for the complain of difficulty in breathing and leg swelling. Previously he had consulted a private doctor in Vadodara and had taken treatment for 15 days. Here, our physician Dr. Vora gave him medicines for 10 days and informed if no improvement then he would have to get admitted. There was improvement after the treatment so he came for follow up and took medicines for a month. Suddenly on 22<sup>nd</sup> Dec 2021, he came to emergency being unconscious. The doctor had examined and referred him to other advanced hospital as there was only 20% chance of survival.

The relative of patient refused for the referral and insisted to continue the treatment at SEWA Rural as desired by the patient. The patient was allotted a bed in the ward just beside the temple. He and his relatives could listen to the prayers twice daily. On seeing the symbols of all the religions in the temple, the relatives brought garlands to offer to the gods inside. Despite being muslim, they prayed to Thakur (Shri Ramkrishna Dev) and wished for the good health of their patient. Knowing all this, hos**p**ital staff had also started praying for his health.

After three days on 28<sup>th</sup> Dec 2021, the patient could open his eyes, could speak and started getting better day by day. A patient who could barely survive, had nor loose faith in the doctors, staff and almighty. Their relatives also supported the staff during the admission. They thaked the staff & doctors.

We are really happy and satisfied to see him going home after getting discharge from the hospital in good health.

# This year there were :

- 5656 deliveries (daily average 15 deliveries)
- 1,02,036 OPD patients ( daily average 340 OPD)
- 17,481 patients were admitted (daily average 48 new patients admitted)
- 72% of patients admitted received free care
- 1,010 newborns admitted in Newborn ICU (daily average 3 new admitted)
- 213 daily average of bed occupancy
- 1,46,669 laboratory tests (daily average 489 Laboratory Test)
- 503 X-ray and 964 ECG tests in a year.
- Total 19160 USG
- 978 Blood Bags used (Daily Average 3 Blood bags)

# Internal medicine (Physician) services:

- 12,280 patients were administered in the OPD and 807 patients were admitted indoors.
- 236 new TB patients
- 12,430 patients in General OPD
- 3,674 patients in sickle cell OPD. At present, 324 patients are on Hydroxyurea. A total of 160 new sickle cell patients were registered.
- We procured a new HPCL Variant 2 Machine for sickle cell screening newborn babies which have been very beneficial.



# **Eye Department:**

- Due to the pandemic, eye camps could not be organized at the village level.
- In January 2021, once the first lockdown was over, an eye camp at the hospital was conducted every Sunday. We screened 1,400 patients and did 216 operations.
- Our paramedical staff conducted a house-to-house survey in Jhagadia and nearby villages. They screened 3,003 homes and counselled 283 patients for operations. Among these, 81 came to the hospital and 53 were operated on free of cost.

# **Government Schemes**

 Of the 17,481 admitted patients, 4,140 availed benefits from various government schemes such as Chiranjeevi, Balsakha, MA Scheme, and PMJAY. Many patients were 'Ma Card' holders, but their diseases were not included in the government's package. All these patients were treated free of charge.

# **Hospital Expansion:**

We place to expand our hospital following all statutory requirements for fire safety. We plan the following:

- 1. 150 new beds
- 2. More beds in the neonatal intensive care unit
- 3. More facilities in labor room complex
- 4. New centralized autoclave sterilize system
- 5. New Operation theater for the elective surgery
- 6. New sewage treatment plant
- 7. Underground parking facilities for the patients and staffs.
- 8. Expand the ICU
- 9. Separate the male and female wards
- 10. New Kitchen and dining facility
- 11. New staff quarters





# The children are spared from being orphans

Shemuben, illiterate and unskilled labourer, had a history of intrauterine fetal death at 7 months in her first pregnancy. Her second delivery happened at home and she has a girl child. This was her third pregnancy and she was coming here regularly for her checkups. She was admitted on 4<sup>th</sup> Feb.'21 and delivered a male child of 2.088 Kg weight. She was suffering from high blood pressure and anemia (deficiency of blood) during pregnancy. At the time of delivery her hemoglobin was 4.2 gms so she was given medications for the same. Although she was critical, she improved and discharged on 8<sup>th</sup> February 2021.

Suddenly on early morning of 10<sup>th</sup> Feb.'21, she was taken to SEWA Rural due to difficulty in breathing. At that time, there was accumulation of fluid in her lungs, her heart stopped working and there was a damage to her kidneys. Immediately, she was intubated and treated for two hours. Her heart had started functioning again but she needed ventilatory support so she was sent to Surat civil hospital in the ambulance with doctor. She was admitted there, was on ventilator for 2 days & then a week in ICU along with blood transfusion.

When we were taking her to Surat, she was worried whether she could survive or not but timely referral and treatment saved her life. During her stay at Surat, we were in constant contact of her.

We are happy to see her alive and healthy along with her husband and two kids.

# **Assistant Nurse Training**

• No new students were enrolled this year. But advanced practical training was started for those who finished general nursing and midwifery training. 6 students benefitted from this advanced training.

# What's New?

- 1. Barcode stickers were added to the registration forms to make it easy to find forms during follow-ups.
- 2. Ophthalmic, Pediatric & Gynecology OPDs were shifted to the afternoon, to ensure patients' safety.
- 3. New medical records department was started.

- 4. New Gynecology OPD with sonography facilities was started once a week at Dediyapada.
- 5. NABH certification procedure was started.
- 6. Dr. Gayatriben Desai was appointed as Medical Director of the hospital.
- 7. Psychiatric O.P.D. was started once a week.
- 8. Entire staff was trained for the Covid pandemic.
- 9. Mock safety drills were conducted at regular intervals.

# **Community Health Project**

# **Goal and Purpose:**

• Conduct various experiments in Public Health so that the highly deprived rural population avail good quality health services. Establish structures so that successful experiments may be effectively applied in other areas.

# A glimpse of major Activities:

# (1) Sickle Cell Care & Research Project:

• ICMR (Indian Council of Medical Research) and NIIH (National Institute of Immunohematology), Mumbai, have started a 5-year research project to investigate sickle cell in newborns and long-term care of sickle cell afflicted children in 7 centres in various states of India. SEWA Rural is one such centre. This year, 1,949 tribal newborns were screened in which 29 were diagnosed with sickle cell. We installed a new HPCL Variant 2 machine at our laboratory for more accurate screening of thalassemia and sickle cell patients.

• We started a new training in which patients can identify early complications of the sickle cell for themselves. We have also started a new detailed treatment plan for them.



- 1,788 sickle cell patients including 161 newborns are regularly getting treatment in the OPD. Apart from this, we have started data gathering and analysis of all sickle cell patients regularly.
- One of our employees, Dr Kapil Dave is doing a PhD in sickle cell.

# I could identify the risk

A 15 years old Payalben from village Pingot is suffering from Sickle cell disease. She has been regularly taking its treatment from hospital since 2019. In the sickle cell clinic she and her relatives were taught about spleenomegaly, when and why spleen enlarges and how to measure it. She was also informed that she must visit an advanced hospital where blood transfusion facility is available on finding large sized spleen.

On 29<sup>th</sup> October 2020, all of a sudden, Payal had severe abdominal pain and she measured her spleen as taught in the clinic. She could identify that her spleen size had increased from normal so she had come immediately to SEWA Rural and on examination by doctor it was found that her spleen was enlarged. She was treated and got discharged after three days. To prevent such condition in future, she was given a medicine named Hydroxyurea.

If such counseling and training on risk identification is provided to patients, many patients could take timely treatment and lead a healthy life. We are happy to achieve this.

# 2. Care of very high-risk newborns program under SNCU follow up project

- After being discharged from SNCU (sick newborn care unit), these newborns have greater mortality than other newborns and need more care at their homes.
- Since April 2018, a trained field supervisors goes to homes in Valia, Jhagadia, Netrang, and Dediyapada talukas to follow up on these newborn babies.
- Follow-up of a total of 1470 children, of which 987 were from the previous two years, was conducted. Among these, 229 children were very high-risk and their regular follow up had been continued.
- Among registered newborns, 83% were tribal, 87% were below the poverty line or in the antoyday category, and 12% belonged to very poor families.
- In children aged from 7 months to 5 years, out of 1243, 11.6% had severe acute malnutrition and 20.4% had moderate acute malnutrition.
- We prepared a mobile application for the project due to which field supervisors can

enter the data correctly, and the follow up is easy and systematic.

# 3. m-Mitra Project

Under them-Mitra project, started by the Armaan organization of Mumbai, 1500 pregnant women were registered in the hospital OPD so that they get healthrelated information through mobiles during pregnancy and later during their care of the newborn.

# 4. Vatsalya Dham


For the past 8 years, SEWA Rural has been instrumental in placing poor orphan children from Jhagadia and nearby areas to VatsalyaDham in Surat to get residential education. Due to the pandemic, new children were not admitted last year. A total of 85 children sent by us have been studying there for the past 8 years.

# 5. Artificial Intelligence Project for accurate measurement of weight of children:

It is important that newborns are weighed accurately in the first week after birth and monitored regularly. At the field level, this is a difficult task to carry out. Wadhwani group, Mumbai has tried to combat this problem with the help of mobile technology and artificial intelligence. They have made software by which, on basis of the child's photo/video, his/her true weight can be measured and noted. This software is being examined in various states and now in Gujarat, by SEWA Rural's help, it is being examined in certain villages of Jhagadia, Dharampur, and Kaprada talukas. We collected the data of 1500 children. In this research, the necessary consent forms and data privacy will be maintained.

# 6. Technical help to JNPCT organization

- For the last 16 years, SEWA Rural has been giving technical help and training to Jashoda Narottam Public Charitable Trust (JNPCT) situated in Dharampur and Kaprada, for their mother-child care project.
- Through JNPCT, a project to eradicate malnutrition has been started in a 90,000 population of 4 PHCs in the interior areas of Dharampur and Kaprada from April 2018. As part of this project, we have been helping in the training of supervisors and frontline health workers (arogyasahelis), making mobile phone applications, and showing them how they can be used in the field.
- Till now a total of 3488 pregnant women have been registered, of which 61% were registered in the first trimester.
- The haemoglobin level of 71% of women was less than 10 gm Haemoglobin at the time of registration.



• In the past 30 months, 88% of the 3-yearolds have moved from SAM (severe acute malnutrition) to MAM (moderate acute malnutrition) or become normal. This is quite an achievement.



# 7. Technical Help in Mother and Child Care project in Afghanistan

From March 2021, SEWA Rural has been giving technical support to International Planned Parenthood Federation (IPPF), South Asian Regional Office, in their Safe mother and child care project in Afghanistan. This project runs for one year.

### 8. Mental Health Project

All frontline health workers need to be trained in mental health. A Goa-based

organization, Sangath had prepared training modules with the help of mobile applications quite some time ago. With the help of the SEWA Rural, a pilot project was conducted in Jhagadia, the results of which are awaited.

# 9. Comprehensive Primary Health Care project

We started a new project on treating noncommunicable and mental health diseases in Pora village in Jhagadia taluka. We got good results and in the coming years, we will expand the project to more villages.

# **Adolescent Awareness Programme**

### **Goal and Purpose:**

- Decrease anemia and give reproductive education to adolescents from ages 10 to 19.
- Develop an ideal demonstration site for Menstrual Hygiene Management.
- Make use of the government's structure to make girls and women aware of menstrual hygiene.

## **Glimpse of Main Activities :**

# 1. Adolescent Tracking Programme

• Using digital technology, the haemoglobin, weight, height, and other health aspects of adolescents are checked. Very high-risk (from the social and health point of view) adolescents are identified, their regular checkups are done and required counselling is given. This was done for all adolescents in 10 villages, 20 schools, and 10 ashram schools. This year 4068 adolescents were registered with the help of a tech platform and 3256 were followed up subsequently. Among these, 33% were found to have some illness and we referred them to the hospital.

### Sickle Cell Disease:

This program is run in a total of 20 schools, 10 ashram schools, and 10 villages. This year 4068 adolescents were registered with the help of a tech platform and 3256 were followed up



subsequently. Among these, 33% were found to have some illness and we referred them to them in hospital.

# • Anemia:

At the beginning of the year, 27 adolescents had severe anaemia(23 girls and 4 boys). Now 6 are normal, 4 have moderate anaemia, and 17 are still severe. To date, 44% of male adolescents and 66% of female adolescents have anaemia (< 11 Gm haemoglobin). Due to the pandemic, they could not get regular treatment on anaemia has become more prevalent.

# Malnutrition:

We found that 76% of adolescents have malnutrition (BMI < 18.5) and 21% adolescents have severe malnutrition (BMI < 14.5).

## Menstrual Hygiene:

Menstrual hygiene kits were given to 803 adolescent girls for a token charge and 80% of these girls use them regularly. Now hardly any adolescent uses old clothes during menstruation.

## • Follow-up:

Due to the pandemic, using digital applications, supervisors could make 95% of their required yearly visits, 80% quarterly visits and 77 to 95%, complicated visits were satisfactory.

# Married Adolescent:

We counselled married adolescents about family planning and reproductive health.

# Evaluation of the Adolescent Program:

Evaluation was done by the IIPH Gandhinagar, in which they used secondary data for analysis and conducted focus group discussions and one-on-one interviews with teachers, peer educators, adolescents, and community leaders. They gave us a few suggestions too.

# • Kite Festival :

We celebrated the kite festival with adolescents and the Covid pandemic was chosen as the theme.

# • Peer Educator Meeting:

We conducted 4 meetings with peer educators, of which 2 were online due to the pandemic. As schools were closed, they keep track of the adolescents and gave them iron tablets once lockdown was over.

# • Teachers training:

We conducted online training for 30 teachers on 17th February. We talked about vulnerable adolescents. They were full of praise for the sincere efforts of our supervisors and their visits to adolescents.

# • Van Bhojan:

We celebrated Van bhojan with adolescents in 247 participated. They met the expenses and also prepared the food.



### Village Awareness:

We conducted an awareness camp at the village level on topics like reproductive health, nutrition, sickle cell, anaemia, menstrual hygiene, and so on. A total of 511 adolescents participated.

### Helpline "mitra":

Due to a technical snag our helpline was not working for a long time. We start all over again and 90 calls were then received regarding reproductive health, education, general health, and menstruation.

### Menstrual hygiene day :

We celebrated menstrual hygiene day on 27th and 28th May at Tekniki Kendra, hospital OPD, community health office, tutorials, nursing station, and the laboratory with the theme of "Red Dot Challenge". We also talked with them about men's participation during menstruation.



**Adolescent Peer Educator's Training** 

### For Staff :

- Our staff was trained in life skills by Shaishav, Bhavnagar, and in adolescent-friendly health by Adolescent health academic, Surat..
- On International youth day our staff also joined online training conducted by FOGSI

# She was spared from being a school dropout

An adolescent girl from Jespor secondary school was found to have only 6.5 gms hemoglobin. Through digital application it was found that she was menstruating twice in a month which could be a reason of her anemia. Her parents and teachers were also informed about her condition and she was referred to Adolescent Health Clinic. After treatment her hemoglobin was increased upto 8 gms.

Another adolescent girl of 10<sup>th</sup> standard from Mission school Jhagadia had 3 gms hemoglobin. We had talked to her mother and she came to hospital with refer slip. She was treated, her anemia was cured and she could continue her education.

We have been helpful to such vulnerable adolescents through regular tracking.



# **Health Training & Resource Centre**

**Goal and Purpose :** Give health training, exposure and expertise to voluntary organizations, government health workers and those working in various departments of SEWA Rural.

## **Voluntary Organizations:**

- 21 supervisors of Jashoda Narottam Charity Trust and Arch, Dharampur were trained in IMNCI (Integrated management of neonatal and childhood illnesses) for a week.
- Online training on menstrual hygiene and care was given to 184 school teachers of the Narmada district.
- Online training and a question-answer session were conducted three times for 85 women and adolescents of Reliance Foundation, Dahej.

# **Foreign students**

• Two MBBS doctors from Russia completed their internship at our hospital.

## **Government Health Worker's**

• Skill birth attendance training was given to 12 nurses of a Primary Health Center in the Bharuch district.

# Students from various Indian voluntary organizations

• Two students pursuing their Masters in Health Administration at the Tata Institute of Social Science, Mumbai did their 6-week NGO posting in SEWA Rural. They studied issues faced by patients in Chiranjeevi Yojana and Bal SakhaYojana, food habits and malnutrition in adolescents, and profiled a village in Jhagadia.

- Five students from Vir Narmad South Gujarat University and MS University conducted a study on village health.
- Twenty-five intern doctors & five resident gynaecologists from Karamsad Medical College, worked at SEWA Rural as part of their placement.
- We have started a Gynecology course "College of Physicians and Surgeons", in which 2 students have joined as residents.

# Coordination Members Workshop

• Two workshops were organized. Various subjects such as the procedure to get Lakshya certification for the labour room, WhatsApp etiquette, self-development, awareness about Covid and the steps taken by SEWA Rural were discussed.

# Self-development of SEWA Rural workers

• During the pandemic, our workers attended online workshops. In the 28



different workshops and seminars attended, 14 workers participated. In 9 workshops, we were the resource person and in 19, we were participants.

- Workers took VIHASA (Values spiritual approach in health care) training from IIPH, Gandhinagar.
- Adolescent staff and peer educators were trained in life skills by Shaishav, Bhavnagar.
- Health supervisors took training in mental health from Dr Ashwinibhai and Nimitaben from the Trust for Reaching the Unreached (TRU).

• Dr. Chitra from PSM department, Karamsad Medical College took a session on 'life skills and bio digital human' for our staff.

# Workshop for new employees

• New employees in SEWA Rural were given a 2-stage training in which SEWA Rural's vision, mission, staff welfare activities, rules for leave, positive approach, teamwork, and other such subjects were taken up. This year in this workshop 22 new employees participated.

# Vivekananda Gramin Techniki Kendra

# **Goal and Purpose:**

- Impart technical training to employ youth from marginalized poor families.
- Make efforts so they become responsible citizens through life and character-building education.

# A glimpse of Main Activities

- Since its inception in 1987, 3083 young men have been trained.
- In July 2020, in the 36<sup>th</sup> batch, 244 trainees were given admission. But due to the pandemic, only 82 trainees joined.
- We continued the training course as per the government Covid guidelines, which required daily monitoring and hard work.
- Training was conducted for welder, electrician, turner, machinist, printer, chemical, fitter, spinning, weaving,



solar, automation, and fire& safety trades.

- Every month, industrial visits are arranged for each trade so that trainees get proper instruction and first-hand experience of industrial work.
- Every month, a workshop on overall life development was arranged with the help of our trained staff.
- A senior and experienced team also trained our staff in creativity, leadership, and dealing with trainees' issues.
- We successfully piloted an online admission application process.
- 52 digital multimeters were given for the electrician, solar, and process automation trades by the Meggar India company.
- A get-together function was organized for the self-employed alumni of VGTK, in which 40 participated. They got guidance from the faculty of the Centre for social entrepreneurship Department (CED).
- One of our trainers, Mr R. K. Patel got trained in manual metal arc welding and teaching from Capital Good Counselling (CGCO) at Larsen and Turbo, Mumbai. Various techniques were taught for the welding course.

- Foundation stone for the two new workshops in VGTK was laid with the help of Birla Century.
- 245 students of the 35th batch finished their training and all of them got employment.
- With the help of Meggarand UNICEF, handwash stations and hygiene kits were prepared for Covid prevention. These kits were distributed in remote areas of the Narmada and Bharuch districts with the help of VGTK and other departments.
- We gave a lath machine worth Rs. 2.5 lakhs to the VGTK alumni who were self-employed. We plan on making a small group of our self-employed alumni.
- With the help of Birla Century, two new trades spinning and weaving have been started with a 100% job guarantee at Birla century.

# **Job work**

- As a part of the training, 20 mattressstands were made in the welder trade. Apart from this,20-25 fabricated stands were made every month for Safari Industries, Bharuch. This practical training improved the skills of the welder trainees.
- We make dishwashers, hand wash, and phenyl in the chemical trade, as per demand. Last year we made



12,000 liters of hand wash and dishwasher.

- The electrician trainees did 350 points of new wiring, 73 points of old wiring and also various electrical work in 12 nearby villages as a part of their practical training.
- The machinist trainees did various job work orders of J. P. Industries, Brakes India, and Raghuveer Industries. This increased their accuracy, standard of work and understanding of production-related issues.
- The printer trainees completed about Rs. 4 lakhs worth of work, which improved their skills.
- The training-cum-production centred about Rs. 45 lakhs worth of work, which enhanced the training.



# What's New?

Due to the pandemic, we faced many issues like the decreased number of trainees, difficulties in hostel management, staff work, gaining the confidence of trainees' parents, the uncertainty of grants and so on. Working together as a team made us solve all these issues in time. We let the staff take responsibility for new products, due to which we gained their self-confidence and also kept them busy during pandemic too. We plan to acquire new job work from industries.

- We took orders from Raghuvir Ind., J. P. Ind., Brakes India, Safari Ind, Chamunda Ind, Megger and Unicef.
- We developed the personal Hygine kit at our center with team work & also distributed it to needy people.
- 42 Handwash Station was made by students and our Instructor team at our training and production center.
   We installed it at various PHC / CHC at Narmada District.

We want that education by which character is built, powers of the mind increase, our intellect develops and we become self-reliant.

# The dreams come true

Ravi Kanubhai Shrimali, Bholav, Bharuch

Ravi's father was not living with them due to some reason. He was residing with his elder sister and mother in a Kuchcha house on the space of railway at Bharuch. His mother was working as a helper in some company to make a living. The company got shut down so his mother became jobless. In such situation, Ravi could not concentrate on his studies so he left school and along with his sister he started working at an Agarbatti Shop. Ravi felt that her sister should be educated so he made her work part time and he himself worked full time in the same shop. His sister restarted her school education.

Meanwhile Ravi got to know about various courses on VGTK from ex-students. In order to complete the course in 6 months and be able to get the job he had taken admission in Solar trade.

In the first month of his studies, his house was demolished due to expansion on railway work, so they had to stay under the railway bridge. Moreover, due to corona pandemic the centre has decided to close the courses. Ravi was very worried as his savings were also decreasing and he could not get any jobwork in that time.

VGTK has decided to start placing their students in industries by declaring their syllabus was completed and industry would train the students after placements. It was communicated to industries in details so the mutual expectations can be fulfilled, we have also insisted on hand holding of such students.

Ravi got placed in "Green Solar Industries, Bharuch" for starting salary of 6000/-Rs. The owner of the Industry Mr. Tarunbhai was made aware about the condition.

Tarunbhai has increased Ravi's salary (8500/-) in only 6 months on seeing his zeal and learning skills, he also sanctioned other allowances and commission on getting orders. Thus, Ravi could now earn upto 12000 to 13000/- Rs. Ravi knows how to save money so his sister is now working at a patrolpump after completing 12<sup>th</sup> Standard. He has rented a house. He has a dream of getting a solar contract in Bharuch in future so he is learning technologies and challenges in order to fulfill his dream. He could repair the solar street-lights of entire Bharuch and lives happily with his family. He dreams big through his small eyes. He manages to achieve his goals during crisis together with his family.

We are happy to see that he did not break in crisis due to team efforts of VGTK and its compassion.



# Sharda Mahila Vikas Society\*

# **Mission :** Help women uncover their hidden strength and thus build a healthy family and society.

**Objective:** Make economically and socially deprived women self-reliant. Include women in educational and awareness programs irrespective of caste, creed or religion

# **Snacks**

- Snacks for hospital patients, sheero (sweet porridge) and mukhvaas (mouth freshener) for postpartum women, sukhadi (sweets) for pregnant women were stopped for a few months due to the pandemic but with the help ofAnasuyaTrust, Mumbai was started again. Snacks for nursing students and the tutorial department continued as before.
- We employed two sahyogi women and an assistant staff member.

# **Garment Department**

- Tailoring work was done by 72 women and due to the pandemic, new types of clothing were prepared.
- 60,401 masks and 504 PPE kits were made.
- Making 21,015 kurtas and 450 shirts was a new experience for all of us.
- Despite the pandemic, all of us worked as per guidelines and completed all orders on time. Sometimes, all the women worked overtime too. Our staff helped everyone.
- **Challenges:** Due to the lockdown, it was difficult to arrange transportation,

got fewer orders from the confirmed parties, could not give enough work at home to some beneficiaries, and had snags in the maintenance of machines and lift. We had trouble making a newly styled kurta and had to do repeat the work a few times till we finally got the required quality. But all of the women worked at it with courage and patience.



## **Sewing Training Classes**

• Due to the pandemic, we could not start training classes on time. We started them in June 2020 but had to stop them again due to the second wave. Only 4 months of training have been completed for 27 trainees and the remaining 2 months will be conducted when conditions improve.

# **Tutorial Department**

- We had to close this year due to the pandemic, but the teachers spent their time preparing learning materials for the students.
- The teachers also worked in other departments as needed.
- Once the lockdown was over, teachers went to the streets in Jhagadia and taught small groups of the students. They also taught them how to prevent corona and prepare home made masks.
- They distributed hygiene kits made by Meggar Company to 103 students families.
- They went to Madhi and Mota Sanja villages to impart basic education to children of migrants.



## Kalrav

• Every year we have a workshop for the children of our staff. This year the workshop was 'aavo maja kariye ane vato kariye' (Come let's have fun and talk) for children above 15. The subject was adolescence, its challenges,

communication with parents at this age and so on. It was conducted by Ms Nimisha Desai from Olakh organization in Vadodara.



# **Other Programmes**

- On 18<sup>th</sup> July 2020, the annual general meeting of the Sharada Mahila Vikas Society was conducted. Yearly accounts were presented and the distribution of profit was discussed. Allocation of incentives, gifts, excursions, and so on was done. A gift was presented to the most industrious woman of the year. We informed our women about Covid, precautions to be taken and so on.
- On 22nd December 2010, Sri Sarada Devi's birth anniversary was celebrated online, in which 50 women participated. The celebration started with bhajans by Sejalben Mandaviya. Then the staff presented some topics based on Dr Lataben Desai's book, "Anantrupini Ma Sharada". Jnanamayaprana Mataji gave an inspiring talk on Mother's words of fearlessness. The celebration was concluded with a bhajan by Kokilaben Pandya.



• On 8<sup>th</sup> March 2021, International Women's Day was celebrated online, in which 50 participated. This year the subject was gender equality and leadership during the Covid crisis. We discussed the positive and negative effects of Covid on women, consequences on finances, education, family, society, and men. Various experts also expressed their thoughts.

# Ilaben Arjunbhai Vasava

Ilaben Arjunbhai Vasava, a quiet female, aged 33 years, married, her education is upto second standard.

She has joined Garment department from 3<sup>rd</sup> July 2020 for stitching. She was neither trained in stitching work nor knew anything about sewing machine. Her husband Arjunbhai is working in spectacle shop at SEWA Rural. She has one kid. Dr. Gayatriben Desai (Trustee of SEWA Rural) suggested that Ilaben should be taught something useful.

So we have started her training of machines. She made doctor's gowns and then did part wise Kurta stitching. She has started with one part and now she is able to sew 3-4 parts with more finishing. Initially, she could earn 2129/- per month and now she could ear upto 5000/- per month. Last month when there was no work of Kurta, she has started learning to stitch shirt and she could complete 4 shirts in a day.

# Safety, Health and Environmental Policy

SEWA Rural firmly believes that poor-centric, value-based work and employees" selfgrowth depends on the safety and health of employees and ability to protect the environment. To achieve these goals, we have designed a safety, health and environmental code.

- 1. While aiming for poor-centric and value-based service, we will not compromise with safety, health and the environment.
- 2. We will duly observe all related legalities.
- 3. Steering committee will be responsible for safety and health. Safety officer/safety supervisor will help them in administration.
- 4. Efforts will be made to develop and impart training in safe work procedure and methods to employees at all levels. To maintain employees' health, regular check-ups will be done and according to their work, necessary arrangements made and education and guidance will be given.
- 5. Safety audits and risk assessments will be conducted by experts and their suggestions addressed.
- 6. Contractors and other agencies will work according to SEWA Rural's safe work methods. It will be their job to inform their employees about safety rules and methods and make sure they get and use whatever tools required for this purpose.
- 7. Safety committee made of members from employees of various departments will meet regularly and their suggestions shall be addressed.
- 8. We will make a clear procedure for observation, operation and emergency response.
- 9. We will make all efforts to keep the organization's environment clean and safe. Use of plastic shall be reduced as much as possible.
- 10. We will put forward the condition of the organization's safety, health & environment in annual reports.
- 11. Without prejudice, we will follow all legalities regarding the organization's safety, health and environment.
- 12. Accidents shall be immediately reported and noted in the register.

All the employees and administrators in SEWA Rural shall work together so that everyone's safety and health is preserved and SEWA Rural may be eco-friendly. This code shall be given to every worker and also any other interested individual.



# Research work done by SEWA Rural and its broader outcomes

- The scope of SEWA Rural's research activities has been growing for the past many years. The kind of research is chosen as per our mission, the capacity of our workers and people's requirement. Some examples are sickle cell genetics, implementation research in adolescents at the community level, experiments in information technology like ImTeCHO, operation research to improve the quality of the hospital work and use of artificial intelligence in community health.
- Our ethical committee has been working for some years to maintain ethical values and make sure that research is done for the public good. Last year two meetings were conducted online and two new studies were approved. To update us on new ethical know-now, Dr. Miraben gave a training session on 'Good Clinical Practice Guideline, New Drug and Clinical Trial Rules, 2019 and National Ethical Guideline for Bio Metrics & Human Research by ICMR', on 6<sup>th</sup> March 2021 at Community Health Department, Gumandev.

### New and ongoing research work :

- 1. Assessment of neonatal screening approaches for sickle cell disease and the effect of early intervention in the management of the disease in tribal populations.
- 2. We did a pilot study for a project called EMPOWER, which is an initiative to build a mental health workforce in the world.
- 3. Epidemiological study of mortality of sickle cell disease patients registered in a comprehen-sive care program in a non-government organization in a tribal area of Gujarat, India.
- 4. Effectiveness of implementing a comprehensive customized care model for individuals with sickle cell disease in a tribal area of Gujarat, India.
- 5. The causes of severe anaemia among pregnant women in tribal areas of Gujarat, India.
- 6. Treatment response for severe anaemia in pregnant women at SEWA Rural hospital, Gujarat.

### **Research Work completed :**

- 1. Created a dataset of short videos, images and measurements of Indian newborns to be used to design and develop a smartphone-based anthropometry tool for newborns.
- 2. Study of the use of menstrual cups to assess uptake and feasibility of cup use among women in rural tribal areas of Gujarat.
- 3. Our 'I am Adolescent' programme 2018-2020 was evaluated by the Indian Institute of Public Health, Gandhinagar.
- 4. Formative evaluation of an implementation model using existing government infrastructure for improving menstrual hygiene management among adolescent girls in tribal areas of Gujarat
- 5. Assessment of nutritional status, knowledge, attitude and dietary practices among adolescents in tribal villages of Bharuch district, Gujarat.

# SEWA Rural's Multipurpose Cooperative Society Ltd.

SEWA Rural's Multipurpose Coperative Society Ltd. for its employees is managed by the employees themselves. On  $20^{\text{th}}$  June 2021, the  $36^{\text{th}}$  annual general meeting was arranged for its 209 members. The total annual profit of the members is Rs. 1, 39, 38, 662 on which we paid 6.5% interest to all members. On the share fund of Rs. 5,47,470, a dividend of 10% was met. Members were given a loan of Rs. 41, 43, 500 and the society made a profit of Rs. 87,113. During the year, educational help, gifts as encourage- ment, donations to SEWA Rural, large scale sale of wheat, rice, onions and so on was done.

# **Educational help :**

- Educational help of Rs. 89, 606 was given to 34 children of the staff for their school fees, whereas Rs. 30,300 were given to4 children for their tuition fees.
- A loan of Rs. 2,31,000 was given to 4 children of the staff for higher education. So far, 40 children have benefitted from this arrangement.

# 'Killol'

 'Killol' baby care centre was started 18 months ago for children from age 6 months to 6 years so that women employees can take care of their children while working in SEWA Rural. This year, 5 children attended Killol.

# Opinion

We have audited the financial statements of SOCIETY FOR EDUCATION WELFARE & ACTION -RURAL (SEWA RURAL) having TRUST REGISTRATION NUMBER - F/110/BHARUCH which comprise the Balance Sheet as at 31st March 2021, related Income and Expenditure Account for the year then ended, and summary of significant accounting policies and other explanatory information for the year then ended.

### **Basis for Opinion**



### **Financial Outlay**

SEWA Rural has now completed 40 years of assiduous journey in reaching out to rural, poor and trials. Generous donations from national and international donors, trusts, CSR funds from industries as well as grants from funding agencies and central and state government has continued. Hence inspite of uncertainties because of Corona Pandemic, an atmosphere of trust persists.




Except for the hospital services, other departments like the community health project, adolescent health project and Vivekananda Gramin Tekniki Kendra did face operational difficulties this year due to the corona pandemic. However we strived hard and could find ways to overcome such difficulties.

During the year, total expenditure of SEWA Rural was Rs. 1,335 lakhs, of which

Rs.1,176 lakhs were for recurring expenses of delivering various services and programs, whereas Rs. 159 lakhs were for non recurring items like construction, equipments and vehicles. Expenditure towards administrative and support services has been maintained at 8%, the barest possible.

Though number of patients availing hospital services also declined due to the



pandemic, but hospital expenses continued. Inspite of receiving partial support through the grant from the state government, there has been a deficit of Rs. 95 lakhs this year. In addition to manage such large deficits year after year, there is a dire need of raising a revolving fund to the tune of Rs. 5 Crores to overcome cash flow crisis as well.



SEWA Rural is now embarking upon a Mega Hospital Expansion Project to accommodate the growing number of patients, improve the range and quality of medical services and to meet the latest statutory norms for hospital buildings. The THREE VERY OLD hospital buildings housed in the present hospital campus including adjacent Ice Factory building will be demolished to have a new basement + ground floor + three floors in EACH of these THREE NEW buildings. Though Mr. Shishir Shah and Nirman Foundation from USA have assured of large sum of funding, we still need about 15 Crores for this ambitious project over a period of next two years. In addition, we need about 100 lacs in managing our Vocational Training Programme.

Because of uncertainties in release of govt. grants and donation inflow during the period of Corona Pandemic, a special donation campaign was initiated during the year. We are happy to report that an unprecedented generous response was received from different stake holders from India and abroad to our special donation appeal. That must be because of SEWA Rural's credentials of reaching out to the poor evolved over the past four decades.

It is estimated that Rs. 30 crores will be required in coming year towards managing various activities and programmes, procuring new equipments and towards completing first phase of our mega hospital expansion project.
